1. A basic recognized medical qualification included in the Schedule to the Indian Medical Council Act, 1956 (102 of 1956).
2. Doctor of Medicine (MD)/Master of Surgery (MS)/Doctorate of Medicine(DM)/Magister Chirurgiae (M.Ch) or equivalent qualification recognized by the National Medical Commission (erstwhile Medical Council of India) in any speciality.
3. The Vice Chancellor shall be a person having minimum 25 years teaching experience, out of which 10 years should be as Senior Professor or on equivalent post in a Medical College/Institution recognized by National Medical Commission. He should have attained National/International status in the field of teaching/research or professional competence.
4. He shall not be below the age of 55 years on the last date of receipt of application.

- i) **The retirement age for the Vice Chancellor is 68 years.**
- ii) **The Vice Chancellor shall hold office for a period of 03 years, which may be renewed for not more than one term.**
